Ice payments may be made in three installments with the first payment due with contract, second payment due by 11/1/18 and third by 12/1/18. **Skaters must have signed contract and first payment submitted PRIOR to taking the ice.** There will be a \$25.00 service charge for all returned checks. All fees are non-refundable.

The deadline for the application is Sunday, September 30, 2018. Any application postmarked after September 30 will be charged a \$15.00 late fee.

PLEASE NOTE: ANY SKATER IN ARREARS MORE THAN 30 DAYS WILL NOT BE ALLOWED TO CONTRACT ICE UNTIL THE BALANCE IS SATISFIED. PER USFS RULES THEY WILL NOT BE ALLOWED TO COMPETE OR TEST. As always, the executive board reserves the right to change any of the above sessions if they should not fill with the adequate number of skaters. You will be contacted ASAP if this should occur.

Walk-ons: Note that SNSHC hourly ice rate is \$15 per hour for SNHSC gold home club members, \$16 per hour for SNHSC blue home club members, and \$17 for non-SNHSC home club members with a signed contract.

The walk-on rates are as follows:

- \$17.00 per hour for SNHSC Gold Home club members
- \$18.00 per hour for SNHSC Blue Home club members
- \$19.00 per hour for Non-club members

Walk-on fees must be paid to the ice monitor before getting on the ice. We will not be billing for walk-on fees.
