Summer contract ice is available on an a la carte basis – you select and pay for the weeks that you know you will attend. There is no refund for weeks you paid for and did not attend, and you may not swap weeks. You can walk on non-contracted weeks for the walk-on rate.

Payment in full is due with contract. **Skaters must have signed contract and payment submitted PRIOR to taking the ice.** There will be a \$25.00 service charge for all returned checks. All fees are non-refundable.

The deadline for the application is Saturday, June 30. Any application postmarked after June 30 will be charged a \$15.00 late fee.

PLEASE NOTE: ANY SKATER IN ARREARS MORE THAN 30 DAYS WILL NOT BE ALLOWED TO CONTRACT ICE UNTIL THE BALANCE IS SATISFIED. PER USFS RULES THEY WILL NOT BE ALLOWED TO COMPETE OR TEST. As always, the executive board reserves the right to change any of the above sessions if they should not fill with the adequate number of skaters. You will be contacted ASAP if this should occur.

Walk-ons: Note that SNHSC hourly contract ice rate is \$15 per hour for SNHSC gold home club members, \$16 per hour for SNHSC blue home club members, and \$17 for non-SNHSC home club members with a signed contract.

The walk-on rates are as follows:

- \$17.00 per hour for SNHSC Gold Home club members
- \$18.00 per hour for SNHSC Blue Home club members
- \$19.00 per hour for Non-club members

Walk-on fees must be paid to the ice monitor. We will not be billing for walk-on fees.
